- Complete application for membership and send to NYS Secretary, P.O.Box 309, San Remo 3925.
- Application is displayed at Club for a minimum of two weeks.
- Invitation issued to prospective member to attend an informal interview together with Proposer and Seconder on a group basis on Committee meeting day.
- Committee will vote on membership application at next Committee meeting.
- Notification will be sent to applicant advising on outcome of application.
- Membership payment request is included for successful applicants.
- Safety Certificate and declaration will be provided for completion.
- A member key will then be issued to new members. Note that keys are not issued to Junior or Absentee Members.
- For current information nomination fees, charges and subscriptions contact the Secretary.
- NYS Membership year commences on the 1st July of each year and on that date annual subscriptions and any other fees shall be due and payable. Notice of dues shall be delivered or posted to the Member's registered address, such delivery or posting shall be deemed to be notice duly given as a first and final request for payment. Any member who fails to pay such subscription within a period of three months shall cease to be a Member. Cases of personal hardship will be considered on merit.
- Clear guidelines regarding a member's rights and behaviour are laid down in the NYS Constitution and Squadron Rules. Members should make themselves familiar with this documentation, a copy of which can be obtained from the Squadron Office.
